The Wasatch Front Regional Council (WFRC), as the Metropolitan Planning Organization (MPO) for the Ogden-Layton and Salt Lake Urban Areas in northern Utah, would like to express support for the Streamline Transit Projects Act. We are grateful for your leadership on this important issue.
