 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "NATO Burden Shar-

5 ing Report Act".

6 SEC. 2. REPORT ON ALLIED CONTRIBUTIONS TO THE COM7 MON DEFENSE.

8 (a) FINDING.—Congress finds that section 1003 of
9 the Department of Defense Authorization Act, 1985 (Pub10 lic Law 98–525; 63 Stat. 2241)—

1	(1) expresses the sense of Congress that, due to
2	threats that are ever-changing, Congress must be in-
3	formed with respect to allied contributions to the
4	common defense to properly assess the readiness of
5	the United States and the countries described in
6	subsection $(c)(2)$ for threats; and
7	(2) requires the Secretary of Defense to submit
8	to Congress an annual report on the contributions of
9	allies to the common defense.
10	(b) SENSE OF CONGRESS.—It is the sense of Con-
11	gress that—
12	(1) the threats facing the United States—
13	(A) include near-peer threats; and
14	(B) require the United States to prioritize
15	military assets and resources in accordance with
16	the most recent National Defense Strategy;
17	(2) the United States should not continue to
18	shoulder a disproportionate share of the burden for
19	European security while current and prospective
20	members of the North Atlantic Treaty Organization
21	neglect to meet defense spending guidelines; and
22	(3) the President should seek from each mem-
23	ber country of the North Atlantic Treaty Organiza-
24	tion acceptance of international security responsibil-
25	ities and agreements to make contributions to the

1 common defense in accordance with the collective de-2 fense treaty to which such country is a party. 3 (c) REPORTS ON ALLIED CONTRIBUTIONS TO THE 4 COMMON DEFENSE.— 5 (1) IN GENERAL.—Not later than March 1 each 6 year, the Secretary of Defense, in coordination with 7 the heads of other Federal agencies, as the Sec-8 retary determines to be necessary, shall submit to 9 the appropriate committees of Congress a report 10 containing a description of— 11 (A) the annual defense spending by each 12 country described in paragraph (2), including 13 available data on nominal budget figures and 14 defense spending as a percentage of the gross 15 domestic products of each such country for the 16 fiscal year immediately preceding the fiscal year 17 in which the report is submitted; 18 (B) the activities of each such country to 19 contribute to military or stability operations in 20 which the Armed Forces of the United States 21 are a participant or may be called upon in ac-22 cordance with a cooperative defense agreement 23 to which the United States is a party; 24 (C) any limitations placed by any such 25 country on the use of such contributions;

1	(D) any actions undertaken by the United
2	States or by other countries to minimize such
3	limitations; and
4	(E) with respect to each such country—
5	(i) the contributions made by the
6	country to Ukraine, including an indication
7	of whether such contributions relate to
8	hard or soft power;
9	(ii) an assessment of the health of the
10	defense industrial base of the country;
11	(iii) the comparative advantages of
12	the defense industrial base of the country;
13	(iv) the size and structure of the mili-
14	tary forces of the country, including an es-
15	timate of the amount of time required for
16	such forces to achieve full military mobili-
17	zation;
18	(v) any area in which the country
19	would be fully dependent on allied military
20	assets;
21	(vi) any delivery received or contract
22	entered into by the country through the
23	Foreign Military Sales or the Foreign Mili-
24	tary Financing program during the pre-
25	ceding year;

1	(vii) any change in defense spending
2	during the preceding year; and
3	(viii) the amount defense spending an-
4	ticipated in the subsequent year.
5	(2) Countries described.—The countries de-
6	scribed in this paragraph are the following:
7	(A) Each member country of the North At-
8	lantic Treaty Organization.
9	(B) Each country participating in a North
10	Atlantic Treaty Organization Membership Ac-
11	tion Plan.
12	(3) FORM.—Each report under paragraph (1)
13	shall be submitted in unclassified form, but may
14	contain a classified annex.
15	(4) AVAILABILITY.—A report submitted under
16	paragraph (1) shall be made available on request to
17	any Member of Congress.
18	(d) Appropriate Committees of Congress De-
19	FINED.—In this section, the term "appropriate commit-
20	tees of Congress' means—
21	(1) the Committee on Armed Services, the
22	Committee on Foreign Relations, and the Committee
23	on Appropriations of the Senate; and

(2) the Committee on Armed Services, the
 Committee on Foreign Affairs, and the Committee
 on Appropriations of the House of Representatives.
